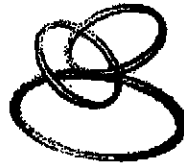

Please visit the GMSDC website for complete information on upcoming events. We design our activities to be informative while enhancing business relationships between MBEs and corporate buyers/executives. I know that your firm will be represented at these networking events.

For access to our new web based system, you will need both the username and password from above. If problems exist -- at the "MBE Login," please click "Here for Password" and at "Password Reminder" then complete the form. The system will generate the appropriate login information. This username/password will provide your firm with access to navigate our system. If the described steps do not work, please email our Manager of Information Services (at info@gmsdc.org) and provide your firm's name, a phone number, and an explanation of need.

Per the new NMSDC guidelines, your firm's recertification will be accompanied with an "additional" site visit once every 36 months. At some point during the year 2008, we will introduce a new online recertification process. All documents will be filled online along with fee payment. PLEASE NOTE: after this certification cycle, your firm will no longer receive an individual faxed invoice and forms. A general "recertification reminder" will appear in our weekly "e-link." This reminder will start appearing at least 90 to 60 days prior to the expiration date and run 30 days after expiration. Also, per the NMSDC Guidelines -- if your firm misses its recertification expiration date, your documents will be removed from both the NMSDC and GMSDC databases and destroyed immediately (PLEASE BE ADVISED -- NATIONAL POLICY). Firms applying for recertification after files are destroyed will have to "restart the entire" certification process. Your firm's timely submittals are appreciated by the entire NMSDC network.

PLEASE NOTE: once we go live online, paying fees with a business check is no longer a payment option. The only way to complete the recertification process is to pay your fees online ... with a business credit card. Credit cards must include the name of the certifying firm. Also, if you have Reciprocal Services with another regional council, the Reciprocal Services certificates will expire on the expiration date on your certificate. At our website, please visit NMSDC AFFILIATES.

Since the GMSDC is no longer warehousing inactive certification files, former certified MBEs that do not complete the recertification process within the prescribed time-frame (described above) will have to restart the entire certification process.
